Todd Callender Interview with the Independent Corona Commission

Todd Callender is a disabled rights lawyer, dealing with Health and Life Insurance, with a focus on the international conventions in the biomedical morbidity and mortality risks in the global legal context. He is also the CEO of a large insurance company in the morbidity business.

Callender has a background in the vaccine industry and his family owns the intellectual property rights to a needle free mass vaccination device. He spent 3 years in Cuba conducting phase 3 clinical field trials (an equivalent to the current situation regarding the purported Co-vacc situation). In this context, he learned a lot about how the vaccine industry operates as he did business with the same people who are now carrying out this genocide, according to him.

In August of 2021 he filed suit against the US DOD (Department of Defence), Health and Human Services and the FDA, in conjunction with the Covid vaccine aftermath (and deaths resulting from the policies surrounding the pandemic).

The World Bank and IMF had put a pandamic bond together and used the claim on that bond, denominated in SDRs (special drawing rights) and for the first time, made the SDRs into a cryptocurrency. This made Callender realize that they had simply implemented the 2005 International Health Regulations in order to make it a global homogenized response and thereby effectively a global military operation.

Callenders group filed suit in order to alert the US military that this was an illegal act according to the Nuremberg Code and the International Convention on Civil and Human Rights, and according to US military statute.

He calls these developments a very well orchestrated genocide in progress and expresses surprise at how few governments seemed to be concerned by these developments, with the exception of a few nations such as Haiti or Tansania, and a few others.

He noted the extreme excess mortality rates in the time following the Covid-vaccine rollout and discusses

the causes for this, in regard to the various vaccine ingredients:

The lipid nanoparticles are like little bombers car

rying payloads of oligo nucleotides, messenger RNA and synthetic DNA. In order to slip these bombers past people's natural immunity they had to disarm the natural immunity with three different HIV proteins.

- GP120,
- AD5 as an adjuvant, and
- PP14.

Those three proteins were injected into humans for the purpose of allowing the lipid nano particle bombers to go into the cells, deliver those payloads and then create synthetic DNA through recombinant mRNA and recombinant DNA.

We also know what the pathogens in some of those shots are.

What is highly alarming regarding the massive excess mortality and morbidity rates, is that the people who put these three HIV proteins into the shots thereby disarmed people's natural immunity and gave them vaccine induced AIDS without giving them anything to reverse it.

So much of what we see in terms of all-cause morbidity and mortality now comes out of the DOD's own database Dmed (Defense Medical Epidemiology Database). Several expert witnesses testified both in the context of the temporary restraining order and preliminary injunction (Dr Theresa Lawrie, Dr McCullough) and helped the group understand the background to this situation from a medical perspective.

When you see a massive increase of hundreds of percentiles in all-cause morbidity and mortality that means something systemic is causing that problem.

With such an abnormal increase in all-cause cancer, heart issues, inflammation issues, blood clotting etc, in a class of people from age 18 to 45 who are physically fit and healthy military people then there is only one cause for that: the destruction of their immune system. That is the vaccine induced immune deficiency syndrome (AIDS). This is now known. The Israelis who are ahead of everybody else have already published papers on this.

- Everybody that got the shot was given some form or level of AIDS (acquired immunodeficiency syndrome).
- after one shot about 30% of natural immunity Is destroyed,
- by the time they get three shots all their natural immunity is completely gone. We are seeing that with our doctors in their practices, on and off- base.

The real epidemic is now!

As the CEO of a large insurance group in the morbidity business that underwrites morbidity risks, disability etc., based on the excess mortality rates of 84% and a 1100% increase for every type of disease we are currently seeing, Callender says we are expecting a 5000% or so increase in excess mortality for 2022.

It is also hardly a coincidence that Moderna has just received licensure of their emergency use authorization (likely multiple dose) HIV vaccine.

So they gave everybody AIDS and here is your salvation.

All of this ties in with the electromagnetic connection to all of this. During the lockdown period of almost 2 years there was a massive installation of 5G networks in the US and several other countries. In the US it was every single public school and most private ones, too. Within this 18 GHz to the 300 GHz range, each one of those signals does different things, including e.g. mimicking the symptomology of Covid.

On Halloween night of 2019, Wuhan was the first city in the world to go 5G, turning on 10,000 transmitters. Within the coming days, you had this massive problem with Chinese people literally falling over dead standing on the street (which is not your usual symptomology with Covid) through their cell phone as the targeting device.

It turns out that the 60 GHz signal (which is within the 5G range) is capable of separating oxygen from nitrogen. Through their cell phone as the targeting device, some people experienced oxygen being ripped from nitrogen: they were breathing in nitrogen, not getting any oxygen, and literally falling over dead.

5G is a dual use item: you can use it to communicate and at the same same time you can use it to kill.

It so happens that a lot of the tests we looked at in the scientific world focused on the 18 GHz signal and found that it interplays with the lipid nanoparticles.

If you look at the patents by Moderna and Pfizer, the Covid pathogen itself was chimeric, it was part bacterial and part viral. We know that now.

The pathogens that were created that are inside of the lipid nanoparticles that are inside the vaccines, are also chimeric. In some cases they are Marburg mixed with E. coli, or they are Ebola mixed with staphylococcus. When these lipid nano particles are exposed to an 18 GHz signal, they swell up and become porous; they then release these oligo nucleotides, the proteins that cause people's bodies to produce these pathogens. That was the whole point of the mRNA technology: to genetically modify people for the purpose of having them produce synthetic proteins.

In the case of Covid it was a specific protein. After the 18 GHz signal it will be other proteins that also produce the same HIV proteins.

When people are subject to these shots, or are producing these synthetic proteins, these pathogens, they are actually also shedding them onto others.

The vaccines were designed to be contagious, in the words of Bill Gates.

So when we look at what will be next, we know it is going to be Marburg. I know that because the Marburg provisions of the US Prep Act have already been put into action. Theoretically speaking there is no Marburg in the US and hasn't been for some time. So why, in March 2020, the Marburg provisions of the Prep Act were invoked and attracted funding for the enabling statute for the Emergency Public Health and Human Services from 2016?

There is a mandate, in the case of a public health emergency, to quarantine people, test people, and they basically have carte blanche martial law provisions, with all constitutional rights suspended and what rights you get are granted by the CDC.

When you look at the confluence of all of these things, including the federal government funded FEMA camps quarantine centres (e.g. in Arizona), it is our contention that this 18 GHz signal will be sent out at some point and it will produce that Marburg haemorrhagic fever result which they will use as a pretext to fill and occupy these quarantine centres, and the hospitals that are already murdering people to the tune of a million or so this last year.

Callender has been involved in trying to get people out of the hospitals who were being kept there to die. In trying to help people escape ICU intensive care, he stumbled upon a number of very interesting aspects:

In 2008, the US government merged public health with law-enforcement, with the judiciary and with corrections. All four of them are now under one roof.

A typical everyday example of such hospital homicides will be that somebody will go to the hospital with a broken arm. They are mandatorily given a Covid test (through the hospitals protocols as they accept federal funding). If the test comes back negative they will be given another Covid test with a higher amplification cycle rate where it will invariably come back positive. At that moment the patient will then be moved to a Covid ward where they are given an IV bag with Midazolam (that's the substance they use for lethal injections). It tranquilizes the lungs and lowers oxygen absorption rates to about 70%. That is then used as the pretext to move them into the ICU ward (70% oxygen is their limit). There they then add Remdesivir into that IV-bag,

then the patients invariably end up on a ventilator which are operating and broadcasting a 60 GHz signal, the same one that separates oxygen from nitrogen. It's only a function of time then when they die from the moment they get on the ventilator.

Callender's job throughout all this has been to prevent these people from getting into ICU and on the ventilator, and to get them out of the hospital.

He explains: I have only had about less than 50% luck in getting people out, because, for instance, if I call the police and tell them this patient did not want Remdesivir, that's a medical battery, we have a criminal complaint: medical battery, medical kidnapping, and enforced imprisonment (these are felonies in the US), the police refused to investigate.

Early on we were able to get Health, Safety and Welfare checks out of the police, so they would actually come and talk to the patient.

This does not happen anymore. Now what happens is that the police will show up and they arrest the loved ones who are trying to be with their family and they drag them away. And this is where I came to understand that the hospitals and public health are a part of the law enforcement apparatus.

Similarly, when I sued the DOD and I got the response of pleadings, it was as though the Department of Justice had responded to a different lawsuit. I looked at it and it didn't make any sense to me who they were responding to here because elements of our case were not even in there. However it turns out that the judiciary has been merged with public health and lawenforcement. What we were seeing were canned pleadings, no different to sueing in a local court.

For example, in an early case in Baylor University Hospital, Texas, there was a patient in ICU were we got a temporary restraining order out in order for us to get an outside doctor to come in and give this person Ivermectin. Within the next day, the hospital lawyer showed up and threatened our judge with the unauthorized practice of medicine. The temporary restraining order was removed and our client was killed.

How do I know this? I have another client who went in, not for Covid but with an aneurysm. The client was nonetheless treated in the exact same manner as described, with Midazolam, Remdesivir, they put them on the Covid ward (he never had Covid), they nevertheless doped them up on Morphine, Fentanyl, a whole cocktail of drugs. So I called the hospital's lawyer and said we want to move him to other care and the hospital's lawyer told me: no, your client is going to die in our hospital. Those were his words.

So I called the chief of police who already had a case with three alleged felonies, and a case number, and I said to the chief I want to do a health, safety and welfare check on my client in the hospital who is not Covid positive but is being treated for it. The police chief said no, I'm not going to go there. Why? The city attorney told me that this was a civil matter and they would not deal with this. So I called the city attorney's office but they would not talk to me. So I went back to the hospital lawyer and told him that this was criminal, and I was going to pursue this criminally. I was given the same response as earlier: your client will die in our hospital.

Callender filed a criminal complaint with the FBI but they would not investigate either and sure enough, the client died in that hospital. Heweighed 78 pounds at the time of the autopsy. He was dehydrated, starved, high on Fentanyl, Morphine and several other drugs, according to the autopsy report.

Callender will be pursuing this matter for the purpose of breaking up the immunity they are granted under the Prep Act, the Care Act and the CMS waiver program, along with the same issues with the Covid mandates with their broad immunity, by proving the involved fraud in order to

vitiate and destroy these protections. In this particular case, he will pursue it on a criminal basis, starting with a civil law suit, to get past the fraud and criminality, to blow those immunities away.

This is a master plan that has been extraordinarily well coordinated from a legal perspective, from a funding perspective, from the perspective of every governmental function, including the elimination of any constitutional charter rights by international law.

All of this arises from Agenda 21, the Agenda for the 21st Century, from the 1994 Rio Climate accords.

The three primary goals are:

- 1. The elimination of private property rights (that's communism)
- **2.** The elimination of borders (look at the mass migration in the United States and Europe, because they want to eliminate sovereignty).
- **3. Sustainable development** (which is in fact a plan for mass depopulation).

We are currently in all three of these phases:

- Klaus Schwab says you will own nothing and be happy,
- Sovereignty is being surrendered (The Organisation for Economic Co-operation and Development is an intergovernmental economic organisation with 38 member countries, founded in 1961 to stimulate economic progress and world trade).
 - At the OECD in 2016 they took the tax and fiscal policies upon themselves, they installed competent authorities that are managed by the OECD; it no longer matters if you've got a prime minister or a president, because the OECD has the authority.
- Mass depopulation: we are there right now through hospital homicides, the triggering signal of 18 GHz and activation of the Marburg or Ebola haemorrhagic fever and the FEMA quarantine camps where they will pick and choose who they want the survivers to be.

There is a scary part in all of this from a legal perspective: a US supreme court case regarding the Association for Molecular Pathology vs Myriad genetics (a landmark case on the practice of gene patenting) from 2013, arising out of earlier cases on genetic engineering and synthetic genomes. On Page 6:

The court finds that use of messenger RNA in particular creates intellectual property rights in the synthetic genome that they create.

What does that mean?

It means that everybody who had the shot whose messenger RNA converted their cells to producing spike proteins are now the chattle property of the intellectual property rights/ patent owners.

That's what this case means and its good law in the United States and there is hardly any other law anywhere in the world that speaks to it or prohibits it. The US Congress has not written anything to overcome this except for a companion statute called the GINA (Genetic Information Nondiscrimination Act) which does not specify who owns the synthetic genome created by the use of messenger RNA.

Plans from NASA and DARPA, dating back to 2001 speak of hybrid humans they will own and

operate.

This is the magnitude of what it is we are up against. This is about the end of humanity. We are talking about an extinction level event were the owners have already pre-decided who's gonna live, who is gonna die, who is gonna become a machine, whom do we own?

When you look at this from a genocide perspective, we have a major fault in the causational elements of our case.

Homicide is the unlawful taking of a human life -what is a human being defined as? Homo Sapiens. These people are no longer homo sapiens- in fact they have already been named as a new species by the name of homo borgenesis.

If they are no longer human, do they enjoy human rights, or the protection of the criminal code? Callender says probably not. So what can you do with your property?

The 13th amendment of the US constitution outlaws slavery defined as the owning of a human. Well, they found a way around it: no different to the case of humanized mice (which already exist), now we have machine-ized, genetically altered humans.

This whole industry is already very developed and there is a serial robot catalogue and a companion on gene therapy out there with a services section where you can (practically) order a flying monkey and they generate the product on the computer, stick it into a nano particle and shoot it out to you.

In their preliminary injunction, Callender's group included mass spectrometry results of the Moderna and Pfizer shots that have shown the presence of SM-102, related to luciferase for tracking purposes, making it possible for them to see who is vaccinated and who is not.

[from Wikipedia and other sources:

SM-102 is an ionizable amino lipid that has been used in combination with other lipids in the formation of lipid nanoparticles. Administration of luciferase mRNA in SM-102-containing lipid nanoparticles induces hepatic luciferase expression in mice. Formulations containing SM-102 have been used in the development of lipid nanoparticles for delivery of mRNA-based vaccines. SM-102 forms part of the drug delivery system for the Moderna COVID-19 vaccine].

So the Pfizer and Moderna shots contain substances which can be identified, and there is also the Bluetooth phenomenon which has been described by many recipients of the vaccine.

Customs agents and airports can already tell the difference if someone shows up with a forged vaccine passport. In the age of digitalisation it is not possible to fake it.

The mass spectrometry of the shots did not show that they contained graphene oxide but they contained the base components for graphene oxide to be produced by the body. One of Callender's experts confirmed that the use of EMF electromagnetic frequency radiation such as cell phone signals will actually cause a 300 % increased formation of graphene hydroxide inside the body.

They just need to put the base chemicals into the user, expose them to a certain level of electromagnetic radiation at a certain frequency, and these people will actually grow graphene hydroxide inside of them.

Morticians have been reporting that they are unable to get the embalming fluid into the cadavers,

and when they open up the blood vessels they pull out sheets with blood clots, and when the blood is washed away what is left are sheets of graphene hydroxide.

What is the purpose of the variable ingredients between different batches of the vaccine?

It is highly likely that different functions and effects are being tested as the vaccine is in the phase 3 clinical trial. In relation to the FDA regulations, the vaccine manufacturers have the opportunity to change the ingredients in phase 3 of the trial prior to the the final application with the FDA. The DOD was behind this; they were the ones commissioning Pfizer and Moderna to do this. The phase 3 clinical trials were designed to test different components.

The manufacturers do not have to tell us what they are testing until their final approval when they have labelling requirements.

According to the various patents as they relate to the pathogens that were carried in the lipid nanoparticles it appears that different people received different doses, and the highest mortality rates were associated with specific serial numbers of those vats.

(German regulators no longer impose labelling requirements at all for the contents of the vaccines, all in the name of speeding up the process of making the vaccination campaign possible. They are also not required to preserve any batches for future investigation- all of which defeats the purpose of any regulation at all, according to Callender).

Füllmich asks the question if the issue of dose levels is actually still the most relevant one, or if the greater issue may in fact be the lipid nano particles.

Callender: All batches contain the lipid nanoparticles, or the hydrogel equivalents as in Astrazeneca, respectively, and all have the HIV component, including Sputnik 5 and Sinovac.

In the disclosure to the FDA as to what these shots are made of, we have polyethylene glycol. Spectrometry tests also show that the ingredients of Moderna and Pfizer where identical except for different portions of polyethylene glycol. The difference between the two types of shots is the programming mRNA and the adenovirus DNA to program the body.

We have no clue what pathogens are inside of those lipid nanoparticles, we just know that the pathogens exist but we have no clue as to who gets what. Some will show up with Marburg, some with Ebola and we would not know. Because they don't have to tell us.

There are three proteins in the shots involved in shutting off the immune system:

- the GP 120
- AD5, a recombinant messenger RNA,
- the PP 14 (from pregnant women's placenta) that attacks cancer T- cells.
- They appear to be in all of the Astrazeneca and Johnson & Johnson shots (that use synthetic DNA as opposed to
- Pfizer and Moderna that use synthetic messenger RNA it accomplishes the same thing)

Unless they actually administered placebo to some people, this means then that everybody who got the shot would get AIDS.

What is the purpose of the additional booster shots?

Two elements of causation behind that: the goal of the exercise is

- to destroy a person's immune system and
- also a control paradigm and the rolling out of the emergency use authorisation for the already existing Moderna (apparently multiple dose) HIV shot.

Last year we already saw demonstrations of Kim Yong-un's genetically modified super soldiers. When you look at what DARPA and DIA came up with, in terms of this frontier, biomechanical war, the new battle field is a genetically modified soldier or person. According to the papers and documents that governments have written about this new battle frontier, to remain ahead of this brand new arms race, constant software updates are required.

Hence Callender thinks that if somebody is left with no immune system whatsoever and they require these brand new HIV vaccinations once a month for the purpose of staying alive (as in: if you don't get your shot you are going to die in 30 days), those additional shots could also act as software updates. The hardware has already been implemented, with the body-assembled graphene hydroxide etc. - that's the main frame.

Bill Gates, Charles Lieber and Craig Venter (the creator of artificial life) have already spoken about this. So once you've got the modified man – machine, how do you upgrade the software to stay competitive in a battle environment? That's what these papers talk about.

Callender's theory is that people are likely to require monthly shots to stay alive, as well as get the software updates for whatever purpose the owners decide.

Dr Wodarg: this will then likely turn into a competition between the programmers on both sides as to who has the better upgrades in this kind of war. A very anti-human agenda.

Callender points out that these individuals don't care about human life, that they hate humanity in fact. The "owners", the people behind the Bank of International Settlement (BIS), the elites, already own the food supply, the water supply, the electricity supply, the labour supply, they own it all.

They are Luciferians and they hate humanity and they have a vested interest in genetically modifying every organism on the planet, starting with us.

This is why it is crucial to inform the police and the military (and any agencies that would be tasked with enforcing the shots) about this agenda that they are often not aware of.

Towards this end, Callender put out a publication in March of last year, about a criminal complaint regarding crimes against humanity (https://vaxxchoice.com/resources/) that experienced many thousand downloads in the first month, including by angry mums and school boards in various countries to alert the executing agencies, particularly the military.

Enhanced ability research:

In 2001 the DOD went into the genetherapy business for the purpose of enhanced abilities development. In this context, in 2005 they got a special exclusion from the Department of Justice that concerns informed consent.

The head of the DOJ determined that for purposes of gene modification, the FDA was no longer involved; Health and Human Services were now in charge. And as for informed consent as

understood under the Nuremberg code this no longer applies in the traditional sense; all you need to do is let people know that you're doing genetic therapy. That means gene modification, and you don't have to even tell them that. You just have to make it so they could find out.

The US military has been doing gene modification at least since 2005 for the prep and purpose of enhanced abilities, the super soldier program. When you check for North Korea super soldiers you'll see that Kim Jong-un already did a demonstration with his guys, where someone tried to hit them with sledgehammers, to no avail. They seem to be puncture proof, and extraordinarily durable, and fast and presumably require less food etc.

Fischer: So it is then possible to transform a human being during their lifetime into an individual with specific abilities; not in the next generation but in the same person.

Callender: They are already at the point of being able to download information straight into the brain. In a case that the army did some years ago, they just took a regular soldier and downloaded information (into his brain) and he was out flying helicopters later that same day. As a pilot himself, Callendar points out that it takes a long time to master those skills under normal circumstances. So that technology already exists.

Füllmich: So Moderna was not joking when they said they were now able to program human beings.

Callender: Indeed. Charles Lieber was really the guy behind that, he is in jail now. According to his 2009 Harvard study, he was able to atomically insert transistors into nano particles and make them independently responsible. They could be programmed and move around autonomously. He also turned nano particles into nano bots that can crawl around in the brain, can deliver their payloads to one particular part of the body etc. He was the man who made all of that possible, along with Craig Venter who created synthetic life and sequenced the human genome.

Three years ago he severed the heads of some pigs, waited 3 days and reanimated the pigs without the heads.

They also did a study with ferrets relating to corona virus; they thought they had killed the ferrets and buried them- but the ferrets survived and three days later they dug themselves out. So there is this extra component also of immortality- if you can imagine that....!

Self-assembling biological graphene is extraordinarily conductive. According to Callender's experts, when someone with graphene hydroxide receives a 2 Ghz signal they will be able to produce a 1 terahertz outbound signal out of that. They will become a battery!

Bill Gates actually has has a patent on this human battery principle.

So these people then become electricity generators. They also become sources of intelligence gathering. Everything that person sees, hears and does is connected to the bio database, to any other such person, to the cell tower and the cloud. They become bio-machines that are capable of detecting everything, sight, sound and touch.

Graphene happens to be the single most durable substance on the planet,
 (so when you see Kim Jong-un's super soldiers being hit with sledgehammers on the head to no avail, it is because you can't even puncture graphene in a single molecular layer)

- it is also self-assembling.
 When you add a teslaphoresis, an electrical current to graphene oxide or graphene hydroxide, it assembles itself into a conductive circuit.
- So they are getting all of those benefits out of graphene. And the people they don't want to use they will just turn off.

The elites appear to have a goal of immortality but Callender is not sure how they intend to achieve that. They want to preserve the resources on the planet with vastly reduced population numbers of humans (Gates, Georgia Guide Stones) down to 500 million people, a 95% reduction of the world's population. The older ones appear to want immortality.

The Bible refers to the notion that those who have taken the Mark of the Beast will desire to die but not be able to do so. So regarding those who receive the shots, as to the question if they are human or not? Probably not.

In the nanoparticles there is also the delivery system of CRISPR technology which is a gene deletion program.

If you look at the curious adverse events from the Pfizer study that came out of the FOIA request, one adverse event they had to disclose is the

- 1p36 gene deletion syndrome.
 That is a congenital disease that causes the loss of the frontal cortex function of reasoning behaviour, produces facial ticks, biting episodes etc. For a person who was not born with it to get it it requires for a gene deletion to have occurred in their body.
- they also deleted the VMAT2, the God gene and
- the PAX5 gene, both pertaining to spirituality.
 These people will not be thinking and act very zombie-like and have no connection to God, no remorse, and no conscience whatsoever, according to Callender.

Fischer: some healers have noticed that some vaccinated people appear to have become unreachable on on a spiritial or energetic level and often don't seem to be thinking clearly, or have become more aggressive.

Callender thinks that these people are likely to already have undergone 1p36 gene deletion.

He comments on how good the elites are at predictive programming for the zombie apocalypse that has been going on for some time. He mentions zombie movies, and Conplan 8888, a US zombie preparedness programme describing five types of zombies.

(Wikipedia: CONPLAN 8888, also known as Counter-Zombie Dominance is a <u>U.S. Department of Defense Strategic Command CONOP</u> document that describes a plan for defending against any zombies. The April 30, 2011 document depicts fictional scenarios of zombie attacks for training students in military planning).

Callender says that every US agency that has had to provide robust protection for their computer system has undergone zombie apocalypse invasions.

The CDC has had a Zombie Apocalypse Preparedness page up on their website for the last five years. Now they have turned it into a cartoon.

Go to Amazon web services where they have a disclaimer that they will not be liable in the case of a zombie apocalypse.

According to Callender, there is too much talk about zombies on the government sites to ignore the 1p 36, combined with a Vmat 2 gene deletion scenarios creating a zombie-like effect in people. They are just telling us what they're going to do: turn on your 18Ghz signal, and you have got a Marburg zombie apocalypse.

Callender says that officially these websites make out that this is just for educational purposes or like a game. Except in preparation for war in the military, you always practice where you fight and whom you'll fight. When you look at Conplan 8888, it has nothing to do with fighting a foreign country- it has to do with fighting five different types of genetically modified zombies. Some are vaccine zombies, or radiation zombies, some are magick zombies. They have five different types of zombies that they are preparing to fight against. It has nothing to do with territory, ideology or insurgency, it is only about zombies.

Shedding

is absolutely real and it is in the published Pfizer testing protocols where they talk about taking care of clinicians who are overseeing the trials because of the shedding problem. The person receiving the gene modification is now producing a synthetic protein, which is an incomplete, a folded protein, producing prions (that can cause mad cow disease).

In March of 2021, Astrazeneca's head of R & D for oncology died from the Creutzfeld-Jakob prion disease. Prions eat away at your brain.

Dr Cole has done a number of autopsies, confirming the presence of prions. Those mutations affect people who have had the shot as well as those around them.

While in BSE just those who had intense body incorporation of prions, such as in organ transplants etc seemed to be developing prion disease, according to Callender, prions are definitely an issue. They are transmittable, jump species etc. In the case of 1p 36 deletion this could also become an issue if it involved biting etc, an exchange of body fluids.

Dr Wodarg points out that there may be a vested interest in depicting the likely scenarios as more dangerous than they actually are, e.g in the case of the promotion of advanced weapons sales. He also cites the Covid scenario as a case of fear mongering on the part of governments who then typically promote a specific counter measure, such as the vaccines (Hegelian dialectic).

The already decided procurement of massive vaccine doses are about the administration of the ever evolving nanoparticle requirements.

The **Convention on the Commercialisation of Lipid Nano Particles** in Texas, in March 2022 was about the nano bot weaponization on a mass scale for the purpose of population control via crop dusting (dropping nano particles from planes flying over cities that then go into people's lungs etc.). Sharing knowledge of the commercilization of the mass production of these lipid nanoparticles with the specifically desired payloads of substances or pathogens. This is also a way of disseminating nano bots. Smart dust is not a new idea.

They need to install the hardware into people first though. There are 3300 commercial products for food that already have nano particles in them (e.g. Pepsi or Coke). Our bodies seem to have the natural ability to expel them- that's why they have to insert the HIV component into the shots to disarm people's immune systems.

Working with scientists and doctors to find remedies, among others:

- chlorine dioxide (which strips away the transistors on the bots).
- also Carbon 60 as well as
- IV chelation therapy.

Cell towers vs satellites:

G5 is a range of frequencies up to 300 GHz that do various things with different ranges.

- The cell towers have 300 Ghz, which is 3 megawatts of energy, which can run a city of 50,000 to 60,000 people.
 - At this wavelength they don't travel very far and are easily distracted.
 - They are beaming microwave energy, the same stuff you cook food with.
 - There are multiple demonstrations of disturbed plants and animals, birds falling out of the sky etc.
- The satellites operate on longer waves which travel much longer distances.
 Every part of the planet is covered, with about 20,000 of them up there. We don't exactly know what the satellites in space emit.

The US government, the DIA, have already done the work for us, have already told us what frequency has which kind of effect on people. E.g. half a hertz can affect our mental state, emotional states. In Australia they recently actually used 96 GHz, literally cooking the protesters.

In the US there are no laws on this, other than regarding the effects from working in this environment.

In 2018, in many parts of the USA they made it a crime for city councils to vote against the installation of 5G.

There are no standards whatsoever, they could cook us all day long. Radiation poisoning can mimic almost any disease.

21 million people in Wuhan got rid of their 5G cell phones. These are targeting systems - that's what the Chinese figured out and ditched their phones.

John Waterman on Caravan to Midnight comments on the healing potential from these towers with harmonic Royal Rife frequencies, while other frequencies can kill people.

Callender is working on a legal basis to turn off the 5G towers through criminal law; there has been some success with that in Australia.

The more this is brought out into the public mind the more action can be demanded. And the higher the chances are for success.
